Subject matter

The Joint Core Strategy for Broadland, Norwich and South Norfolk sets out the vision, objectives and strategy for the spatial development of the area covering the period 2001 to 2026. It includes the broad locations for future development, and details policies to guide new development, including policies that protect the environment, and secures implementation in a way which promotes sustainability and the effective functioning of the whole area.

Area covered

The Joint Core Strategy covers the area of the three local councils, except for those parts for which the Broads Authority is the local planning authority.
