## GNDP JOINT CORE STRATEGY PUBLIC EXAMINATION – INSPECTORS' CHANGES TO BE ADVERTISED

I was at the last public hearing of the above document and since then I have received notification from the Programme Officer with regard to the above.

This notification was dated 30<sup>th</sup> December and advises interested parties of the need to advertise the possible changes to the JCS and gives a cut off date of Wednesday 2<sup>nd</sup> February. This is not my, or my colleagues from SNUB and other community groups, recollection of your stated intention.

You may recall that your advice was that these changes were substantial enough to warrant a full 6 week consultation and in the course of that decision you rebutted the approach from legal council of the GNDP who was arguing that these changes were insignificant and they could be advertised with 4 weeks allowed for the responses.

Furthermore I seem to recollect that you stated that any communications should be sent out after the holidays, which we all took to be in early January. As you will note this latest missive was sent on the 30<sup>th</sup> Dec and provides just over 4 weeks for response. Furthermore the documents issued with these changes are currently running at 50 pages with no guarantees that there will not be more. This confirms the fact that these changes are material and require sufficient time for a qualitive response.

We now have a situation whereby the chance for community groups, such as ours and Parish Councils, to meet and digest these changes is limited by the completely unnecessary haste. If we are to consult with local residents then we need sufficient time to communicate these changes, facilitate meetings to gather responses and

then to commit this to one electronic copy and three hard copies. Hardly conducive to consultation as promoted by the Aarhus Convention.

We all believe that the timetable should have been along the lines of a letter dated Monday 10<sup>th</sup> January with responses required by Friday 20<sup>th</sup> February thus permitting groups who are, in the main, organising the response in their spare time. I would appreciate your views on this and your support for this extension of the deadline for these reasons.

Incidentally you may also like to know that despite your view that you saw no reason why the GNDP should not allow members of the public into their meetings they have still decided to hold their meetings in private.
