Introduction

Introduction

- 1.1 This is the Playing Pitch Strategy (PPS) Action Plan for Greater Norwich, which has been developed by FMG Consulting Ltd (FMG). The area known as Greater Norwich is now overseen by two separate partnership boards; The Greater Norwich Development Partnership (GNDP), who oversee the development of the emerging Greater Norwich Local Plan and the Greater Norwich Growth Board (GNGB), who oversee the strategic delivery of infrastructure that is required to support the planned growth.
- 1.2 The strategy has been developed in accordance with Sport England Playing Pitch Strategy guidance and updates current supply and demand information within the three Local Authority areas, covering the public, private, educational, voluntary and commercial sectors.
- 1.3 The information contained within the PPS will provide an evidence base to protect existing provision and ensure that future demand can also be catered for. It will also help to inform planning decisions and developer contributions.
- 1.4 The PPS is also being developed in tandem with a Greater Norwich Physical Activity and Sport Strategy (PASS) and Built Facilities Strategy (BFS). Together they provide a holistic approach towards the provision of sport and physical activity within the three Local Authorities and will run up to 2038, in line with the emerging Greater Norwich Local Plan (GNLP).
- 1.5 A vision and mission for the PPS has been developed by the project team and sets out what is trying to be achieved and why.

Vision

1.6 *"To enhance the health, well-being and quality of life of our residents by creating opportunities for and inspiring people to become more active."*

Mission

1.7 "To provide top quality outdoor sports provision, to meet current need and future demand."

Aims

- 1.8 The PPS will also follow the three overarching aims recommended by Sport England, which are:
 - 1. Protect existing pitch provision up to 2038;
 - **2. Enhance** pitches and ancillary provision by improving the quality and management of facilities;
 - 3. Provide new pitches and ancillary provision where there is demand.

Agreed Scope

- 1.9 The following outdoor pitch sport facilities have been included as part of the strategy:
 - Football;
 - Rugby Union;
 - Cricket;
 - Hockey.
- 1.10 The following outdoor non-pitch sport facilities have been included as part of the strategy:
 - Tennis;
 - Netball;
 - Bowls.
- 1.11 The three assessment reports were completed and signed by the project steering group which includes representation from each of the following organisations.
 - Norwich City Council;
 - South Norfolk Council;
 - Broadland District Council;
 - Greater Norwich Growth Board;
 - Norfolk County Council;
 - Sport England;
 - Norfolk Football Association (Norfolk FA);

- The Rugby Football Union (RFU);
- England Hockey;
- The England and Wales Cricket Board (ECB);
- Norfolk County Cricket Board;
- The Lawn Tennis Association (LTA);
- Bowls England.

Covid 19

- 1.12 The development of the PPS started in May 2021 whilst there were still some lockdown measures in place in England. These measures were eased in July, which is when the summer sport pitch assessments started. These were then completed in August 2021.
- 1.13 The previous sport season had been affected by lockdown restrictions, which restricted people from gathering in large groups outdoors. Therefore, Summer 2021 was the first full uninterrupted season for summer sport and the 2021/2022 season was the first uninterrupted season for winter sport.
- 1.14 At present it is unknown what long term impact the lockdown restrictions have had on participation numbers for sport or what, if any, impact there has been on the quality of sport pitches due to restricted use.
- 1.15 Given this, it is imperative the Stage E process for the PPS is followed, to ensure the supply and demand data can be reviewed and updated where necessary and account for any changes.

The Study Area




Figure 1.1 Map of the study area

1.16 The study area will include the joint administrative areas of Norwich City Council, South Norfolk Council and Broadland District Council. The PPS builds upon the findings of the three individual Assessment Reports that have been completed for each Local Authority area. 1.17 Figure 1.1 shows the study area comprising of the 3 Local Authority areas.

Keeping the strategy robust and up to date

- 1.21 The strategy has been developed in conjunction with the PPS steering group. It is important that this group now remains in place beyond completion of this strategy, to ensure that it is kept up to date.
- 1.22 It is recommended that the steering group meets at least once a year to update the data and review delivery of any projects identified within the action plan. As a guide, if no review and subsequent update has been carried out within three years of the PPS being signed off by the Steering Group, then Sport England and National Governing Bodies (NGBs) would consider the PPS and the information within it to be out of date. If the PPS is regularly reviewed and kept up to date it can remain valid for five years.
- 1.23 It is the responsibility of the three Local Authorities to coordinate the review meetings, with support from steering group members. If any members leave the steering group, it is that organisation's responsibility to ensure an adequate replacement is provided.
- 1.24 A copy of the Stage E Checklist has been provided in appendix B.

Sport Specific Issues and Scenarios

Introduction

2.1 This section of the report looks at the issues that were identified for each sport within the Assessment Report and provides an overview of these issues within each Local Authority area. Certain scenario testing has been agreed with the NGB's, which has also been applied to look at what impact this would have on provision for that particular sport.

Norwich

- 2.2 Table 2.1 overleaf provides an overview of the current (2022) and future (2038) capacity of playing pitches in Norwich. Capacity is measured in match equivalent sessions (MES).
- 2.3 As team number are limited within each of the sub analysis areas for Norwich, all the information provided in table 2.1 is on a Norwich wide basis

Table 2.1 shows current (2022) and future (2038) capacity of playing pitches in 2.4 Norwich.

2.5 The following is a summary for each individual sport, which lists the key findings and issues that were identified in the assessment report for Norwich.

Football Summary

- There are 23 sites in Norwich that currently provide grass football pitches, this amasses to 53 pitches. In total 37 of these football pitches are available for community use;
- There are a number of clubs accessing pitch provision on school sites where community use is deemed to be unsecured;
- There are currently 4 pitches assessed as being good in Norwich, 31 as standard and 2 as poor;
- There are currently 2 sites containing football pitches available for community use that have ancillary provision assessed as good. There were 4 sites where ancillary provision was assessed as standard and 3 as poor;
- There are 25 clubs in Norwich who between them field 86 teams;
- There are 29 teams of imported demand from outside Norwich accessing pitch provision within the Local Authority area. There are also 7 teams in Norwich who have exported demand which takes place in Broadland;
- Team Generation Rates calculate that there will be 5 new teams created up to 2038 in Norwich, all of which are adult teams;
- In total there are 5.5 Match Equivalent Sessions (MES) of spare capacity across all football pitch types in Norwich. The greatest amount of spare capacity is on mini soccer 5v5 pitches. At present there is no spare capacity on any pitch type in the East or West sub analysis areas;
- There are current shortfalls on youth 11v11 and youth 9v9 pitches of 2 MES for each pitch type. Those shortfalls remain the same when future demand is taken in to account. Adult pitches are currently at capacity, although there is a shortfall predicted when future demand is taken in to account, this amounts to 2.5 MES. There is currently spare capacity on both mini soccer pitch types (5v5 and 7v7) which isn't expected to be impacted by any future growth

Third Generation (3G) Artificial Grass Pitch (AGP) Summary – Football

- There are currently 28 3G AGPs in Norwich across 7 sites. 2 of these pitches are deemed to be full size whilst 26 are considered small sized;
- There are 2 3G AGPs in Norwich that aren't currently available for community use, 1 is located at Her Majesties Prison Norwich and the other is located at Notre Dame Prep School;

- A new full size 3G AGP has recently been developed at the Football Development Centre (FDC);
- Both full size 3G AGPs are on the Football Association (FA) 3G Pitch Register. None of the smaller sized 3G AGPs are at present;
- During consultation, both sites containing full size 3G AGPs stated they were at full capacity;
- The 3G AGP at Open Academy was assessed as standard. It is assumed that the new 3G AGP at the FDC is good quality;
- Both sites have ancillary provision that was assessed as good. Norfolk FA reported plans to upgrade some of the changing room provision at the FDC;
- Based on current and future team numbers in Norwich there is not enough demand for any additional 3G AGPs.

Rugby Summary

- There are currently no rugby clubs based within Norwich. All demand for rugby provision is picked up in neighbouring authorities. The RFU stated that they have no issues with this;
- There are currently 7 rugby pitches identified within Norwich across 4 sites. 3 of these are senior rugby pitches and 4 are junior rugby pitches;
- The majority of pitches are provided in the South sub analysis area, 4 in total. There are 2 in the East and 1 in the West. There are currently no rugby pitches provided in the North;
- All 7 rugby pitches were assessed to determine their quality, 5 were assessed at standard and 2 as poor. Both of the poor pitches are the only pitches in Norwich that are currently available for community use;
- All sites in Norwich that provide rugby pitches also provide ancillary provision;
- There is only 1 site in Norwich that is deemed to have actual spare capacity, which is Eaton Park. This totals 0.5 Match Equivalent Sessions (MES);
- No rugby pitches in Norwich are currently overplayed.

Hockey Summary

- There are currently 2 sites in Norwich that provide full size AGPs suitable for hockey, both of which are double pitch sites and available for community use;
- There are also 3 sites in Norwich that provide small sized AGPs suitable for hockey. Only 1 of these pitches is currently available for community use, that's the AGP at Norwich High School for Girls;

- There are 3 hockey clubs in Norwich currently who field 35 teams. This equates to 14 senior men's teams, 13 senior women's teams, 4 junior / mini boy's teams and 4 junior / mini girl's teams. University of East Anglia (UEA) Hockey Club only caters for students from UEA;
- UEA Hockey Club and Norfolk Nomads currently use Sportspark where community use is deemed unsecured. There are no issues with security of tenure at Town Close Hewett (TCH) Dragons Den;
- The AGPs at Sportspark were assessed as being good quality and the AGPs at TCH Dragons Den were assessed as being standard quality;
- Ancillary provision at both sites was assessed as good. Although it should be noted that Norwich Dragons currently access ancillary provision at Goals Soccer Centre Norwich, who they share a site with. Whilst the quality of the facilities are good, the club have to share them with Goals users, and they aren't the correct size. The club are keen to explore developing their own ancillary provision in the future;
- Sportspark currently has 7 hours of spare capacity during mid-week peak times. They also currently have 2 MES of spare capacity during the weekend. TCH Dragons Den is at capacity midweek and weekends.

Cricket Summary

- There are currently 7 grass cricket squares in Norwich across 5 sites that provide 37 wickets in total;
- Only 2 sites currently provide community use for grass wickets, City of Norwich School and Britannia Barracks;
- There are 3 sites that contain lapsed cricket squares, those are, Angel Road Infant School, Hewett Academy and Open Academy;
- There are currently only 2 teams playing competitive cricket in Norwich. Both of these field senior men's teams and play at City of Norwich School;
- All sites containing grass cricket wickets were assessed to understand their quality. 1 was assessed as good, 2 as standard and 2 as poor;
- All demand for competitive cricket currently exists in the South sub analysis area. It is understood that demand in the North sub analysis area is catered for in Broadland;
- The only site in Norwich where competitive cricket takes places is City of Norwich School. This site is overplayed by 12 match equivalent sessions (MES);
- Ancillary facilities on cricket sites available for community use were also assessed. 1 site was assessed as standard, this is City of Norwich School and the other was assessed as poor, this is Britannia Barracks;
- There is currently no spare capacity available on grass cricket wickets in Norwich for Saturday, Sunday or mid-week cricket.

Tennis Summary

- The NTA are a key operator and provider of tennis in Norwich. They oversee the Norwich Tennis Parks programme which is an example of best practise by the LTA;
- There are currently 54 tennis courts in Norwich across 13 sites;
- All 54 tennis courts are available for community use;
- 32 courts available for community use have floodlights;
- Of the 54 tennis courts available for community use in Norwich, 45 are a macadam surface. There are 3 acrylic courts, 3 concrete courts and 3 Artificial Grass Pitch courts;

- A number of sites have recently had their courts resurfaced or are about to. These sites include Harford Park, Heigham Park, Lakenham Recreation Ground, City of Norwich School and East Anglia Tennis and Squash Club;
- There is unsecured use recorded at City of Norwich School, Norwich High School for Girls and Sportspark;
- The NTA are renegotiating their lease agreement with Norwich City Council for the park sites they operate;
- There were 24 tennis courts available for community use assessed as being good, 24 as standard and 6 as poor;
- Issues with access to toilet provision in park sites was identified as an issue through the consultation;
- There are high levels of imported demand in Norwich which results in a number of sites being overcapacity. These sites all fall under the Norwich Parks Tennis programme.

Netball Summary

- The Norwich Netball League is the only netball league that operates in Norwich. This is a central venue league ran at 3 venues within Norwich on different nights of the week. The league runs indoor and outdoor leagues spanning the summer and winter months;
- The 2 largest clubs in Norwich are Norfolk United and Thoroughbreds. Both clubs have teams who compete in the National League. The only venue locally that can cater for these fixtures are the indoor courts at Sportspark;
- There are currently 9 sites in Norwich which provide outdoor netball courts for community use. This equates to 25 courts in total;
- 18 of the 25 netball courts in Norwich are floodlit;
- 12 netball courts were assessed as good, 13 as standard and 0 as poor;
- Consultation identified issues with the court quality at City Academy Norwich. The Norwich Netball League stated that they would like to explore options to resurface the courts.

Bowls Summary

- There are currently 5 sites in Norwich that provide bowling greens;
- There are 2 disused greens, 1 at Heigham Park and 1 at Norfolk Bowls Club;
- Of the 5 greens currently available for community use, 2 were assessed as good, 1 as standard and 2 as poor;

- Access to ancillary provision was identified as an issue at Alderman Walker Park through the consultation;
- Lack of access to car parking was identified as an issue at Heigham Park;
- None of the bowling greens in Norwich are floodlit;
- Based on clubs who responded to the consultation, there are currently 342 adult bowls members within Norwich and 4 junior members. With planned club growth this could increase to 356 adult members.

South Norfolk

2.7 The following is a summary for each individual sport, which lists the key findings and issues that were identified in the assessment report for South Norfolk.

Football Summary

- There are currently 66 sites in South Norfolk that provide grass football pitches, this equates to 159 pitches in total, 126 of these pitches are available for community use;
- There are a number of clubs in Broadland accessing pitch provision on school sites where community use is deemed to be unsecured;
- There are 40 pitches that were assessed as being good quality in South Norfolk, 68 as standard and 18 as poor;
- There are currently 15 sites containing football pitches available for community use that have ancillary provision assessed as good. There were 22 sites where ancillary provision was assessed as standard and 6 as poor;
- There is only 1 team of imported demand in South Norfolk, this demand comes from Broadland;
- There are 2 clubs in South Norfolk who have exported demand outside of the Local Authority area. This equates to 13 teams in total. Costessey Sports have 7 exported teams to Broadland and Morley Youth FC have 6 teams exported to Breckland;
- Through the consultation, clubs in South Norfolk reported plans to grow an additional 44 teams across all formats of the game;
- Team Generation Rates (TGRs) calculate that there will be 62 new teams created up to 2038 in South Norfolk;
- In total there is actual spare capacity of all pitch types amounting to 34.5 Match Equivalent Sessions (MES). Broken down by sub analysis areas there is 9.5 MES of actual spare capacity in the East sub analysis area, 15.5 MES in the West and 9.5 in the South. The greatest amount of actual spare capacity currently exists on adult football pitches;
- The greatest amount of overplay is currently found on youth 11v11 pitches with 6.5 MES it total. There is overplay totalling 5.5 MES on youth 9v9 pitches and 3.5 MES on adult pitches. No mini soccer pitches were recorded as being overplayed. Overplay in South Norfolk across all pitch type equates to 15.5 MES;
- There are future shortfalls predicted on youth 11v11 and youth 9v9 pitches in both the West and South sub analysis areas. The East sub analysis area has future shortfalls predicted on youth 9v9 pitches. No future shortfalls are identified on any other football pitch types in South Norfolk.

3G AGP Summary – Football

- There are currently 8 3G AGPs in South Norfolk across 5 sites. 2 of these pitches are deemed to be full size whilst 6 are considered small sized;
- 3 3G AGPs in South Norfolk are currently unavailable for community use. All 3 are located at Norwich City FC's training ground;
- The University of East Anglia are currently developing plans to provide a new full size 3G AGPs at their sports ground site. It is understood that this will also have a shock pad, making it suitable for contact rugby training;
- Both full size 3G AGPs are on the FA 3G Pitch Register, as is the smaller sized 3G AGP at Long Stratton Leisure Centre;
- Through the consultation both sites containing full size 3G AGPs identified minimal availability during non-peak hours. During peak periods both pitches are fully utilised;
- The full size 3G AGP at Kett's Parks Community Recreation Centre was assessed as good, whilst the 3G AGP at Easton and Otley College was assessed as standard;
- Ancillary provision at Kett's Park Community Recreation Ground was assessed as standard, whilst the ancillary provision at Easton and Otley College was assessed as good;
- There is currently demand for 6 3G AGPs in South Norfolk. This remains the same when TGRs are combined with current team numbers.

Rugby summary

- There are currently 42 rugby pitches within South Norfolk across 11 sites. 25 of these are senior rugby pitches, 3 are junior rugby pitches and there are 14 mini rugby pitches;
- The majority of pitches are provided in the West sub analysis area, 27 in total. There are 8 in the South and 7 in the East;
- 30 out of the 42 rugby pitches in South Norfolk are available for community use;
- There are 6 rugby pitches assessed as good in South Norfolk, these are all located on educational sites. 30 pitches were assessed as standard and 6 as poor;
- All sites that are used by rugby clubs provide ancillary facilities that were assessed as good;
- Clubs in South Norfolk reported future growth of 3 youth girl's teams;

- There is actual spare capacity of 10.75 MES across all rugby pitches in South Norfolk. The majority of this is located in the West which has 8.75 MES of actual spare capacity;
- There is overplay totalling 18.5 MES on rugby pitches in South Norfolk. 3 out of 4 rugby club sites have pitches that are overplayed. The greatest amount of overplay currently existing in the West sub analysis area where there is overplay totalling 14.5 MES. All overplay currently exists on senior rugby pitches;
- There are current shortfalls on senior rugby pitches in the South sub analysis area amounting to 4 MES and 13.25 MES in the West sub analysis area. Shortfalls in the West sub analysis area increase by 0.5 MES when future team demand is considered.

Hockey summary

- There are currently 3 sites in South Norfolk that provide full size Artificial Grass Pitches (AGPs) suitable for hockey, 2 of these are available for community use; There are also 2 sites in South Norfolk that provide smaller sized AGPs suitable for hockey. Both of these pitches are available for community use;
- There are 3 hockey clubs in South Norfolk who between them field 5 teams. All 5 of these teams are senior women's teams;
- There is 1 team of imported demand in South Norfolk, this is imported from Beccles Ladies Hockey Club and is imported from East Suffolk;
- All hockey club demand is located at Langley School where security of community use is deemed to be unsecured;
- Both full size AGPs in South Norfolk that are available for community use were assessed as standard. All hockey clubs who use Langley School did raise minor issues with the quality of the surface;
- Ancillary provision at Langley School was assessed as being good, although all hockey clubs that use the site raised issues with the proximity of the facilities to the AGP;
- Team Generation Rates (TGRs) suggest that up to 1 additional senior women's team will be created in South Norfolk up to 2038;
- There is spare capacity amounting to 13.5 MES at weekends on full size AGPs suitable for hockey in South Norfolk. There is also mid-week capacity for training at Hobart High School.

Cricket summary

- There are currently 28 grass cricket pitches in South Norfolk across 18 sites. 16 sites provide community use. The 2 sites that are unavailable for community use are both educational sites;
- There are 3 sites that contain lapsed cricket squares, these are Archbishop Sancroft High School, Diss High School and Loddon Junior School;
- There are currently 16 cricket clubs within South Norfolk with a total of 120 teams. There are 33 teams located in the East sub analysis area, 67 in the West and 20 in the South;
- Security of tenure is deemed to be an issue at 8 sites in South Norfolk, Both Bungay Cricket Club and Topcroft Cricket Club have annual rolling agreements at their sites. Swardeston Cricket Club have no agreements in place for both sites that they use and none of the 3 clubs who use the University of East Anglia have any security;
- 1 club have exported demand this is Diss Cricket Club who currently access Eye Cricket Club in Suffolk. This is due to a close working relationship between the 2 clubs;
- There were 10 grass cricket pitches assessed as good, 13 as standard and 0 as poor. There were also 9 Non-Turf Pitches (NTPs) assessed as good, 5 standard and 3 poor;
- Team Generation Rates show future demand for an additional 18 cricket teams in South Norfolk;
- Ancillary provision at sites containing cricket squares was also assessed. 7 sites were assessed as having good quality provision, 7 as standard and 4 as poor. Hales and Loddon Cricket Club reported that their current ancillary provision was in a state of disrepair;
- Whilst 11 sites provide access to nets for training sessions, both Hales & Loddon Cricket Club and Saxlingham Cricket Club reported that they require additional practise nets. Some clubs also use grass wickets to train on;
- There is actual spare capacity for 2 Sunday teams in South Norfolk. There is no actual spare capacity for Saturday or mid-week teams;
- There are 8 sites in South Norfolk which contain overplayed squares, these total overplay of 200 match equivalent sessions (MES).

Tennis summary

• There are 27 sites in South Norfolk that provide outdoor tennis courts. This amasses to 82 courts in total;

- 69 of these courts are available for community use;
- 35 tennis courts available for community use have floodlights;
- The majority of tennis courts provided in South Norfolk have a macadam surface (69%);
- Wymondham Tennis Club based at Ketts Park Community Recreation Centre are due to have their courts resurfaced. An additional court will also be provided bringing the total number of tennis courts on site to 4;
- Provision is deemed to be unsecured on 3 club sites, these are Diss and Heywood Tennis Club, Easton & Otley Tennis Club and Edge Tennis;
- 23 tennis courts were assessed as good, 40 were assessed as standard and 6 as poor;
- 3 clubs reported plans to increase their current membership levels by a total of 140 adult members and 45 junior members;
- There is only demand for an additional 15 members on existing club sites in South Norfolk;
- 2 sites currently have spare capacity whilst there are 3 sites that are over capacity.

Netball summary

- There is no netball league based within South Norfolk. The South Norfolk Netball League is hosted at Rickinghall Recreation Ground which is in Mid Suffolk;
- There are currently 9 sites in South Norfolk providing outdoor netball courts. This equates to 24 courts in total. 8 sites are available for community use which provides 18 courts in total. 2 of these are Parish Council sites, the rest are educational sites;
- There are 10 netball courts in the South sub analysis area and 4 each in the East and West sub analysis areas;
- Of the 18 netball courts available for community use, the majority are a macadam surface, 11 in total. There are 2 artificial courts and 5 concrete;
- Of the 18 netball courts available for community use, 9 are also floodlit.;
- 4 netball courts were assessed as good quality, and 12 as standard. 0 courts were assessed as being poor quality;
- The South Norfolk Netball League reported there has been a drop in team numbers due to the pandemic;
- They also reported aspirations to find a venue within South Norfolk to host the league as this is where all the teams are based.

Bowls summary

- There are 14 sites providing bowling greens in South Norfolk. 9 of these are in the South sub analysis area, 3 are in the West and 2 in the East;
- There were no bowling greens reported as lapsed or disused in South Norfolk;
- 12 of the 14 bowling green in South Norfolk were assessed. 4 were assessed as good and 8 as standard. 0 bowling greens were assessed as being poor;
- All sites have access to some form of ancillary provision;
- No bowling greens in South Norfolk are floodlit;
- There are currently 896 bowls members across clubs in South Norfolk. This breaks down to 893 adult member and 3 junior members;
- There is currently spare capacity across bowling greens in South Norfolk for 404 members;
- Consultation identified future growth of 172 members in total at clubs within South Norfolk;

• There should be sufficient capacity on existing bowling greens to cater for future demand in South Norfolk.

2.9 The following is a summary for each individual sport, which lists the key findings and issues that were identified in the assessment report for Broadland.

Football summary

- There are currently 60 sites in Broadland that provide grass football pitches, this equates to 168 pitches in total. 143 of these pitches are available for community use across 46 sites;
- Tenure is deemed to be unsecured on 2 football sites in Broadland, Sprowston Cricket Club and Sprowston Sports & Social Club;
- There are currently 49 pitches that were assessed as good in Broadland, 80 as standard and 13 as poor;
- There are currently 16 sites in Broadland containing ancillary provision that was assessed as good.13 sites containing ancillary provision assessed standard, and 12 assessed a being Poor. Buxton FC reported concerns with the quality of their ancillary provision through the consultation;
- In total there are 12 teams of imported demand accessing grass football pitches in Broadland. 5 teams are imported from Norwich and 7 teams are imported from South Norfolk;

- There are currently 18 Broadland teams who have exported demand and are accessing pitch provision outside of the Local Authority area;
- Through the consultation, clubs in Broadland reported plans to grow an additional 50 teams across all formats of the game. Wroxham FC reported that they would like to grow a new team at each age group but would require additional facilities for this;
- Team Generation Rates (TGRs) calculate that there will be 65 new teams created up to 2038 in Broadland across the various age groups;
- In total there is actual spare capacity of 27 MES in the East sub analysis area and 13 MES in the West. This totals actual spare capacity of 40 MES across all football pitch types within Broadland. The largest amount of spare capacity is currently on adult pitches and mini soccer 5v5 pitches;
- The most amount of overplay exists on youth 11v11 pitches this is currently 12.75 MES. There is overplay of 5.25 MES on adult pitches, 7.5 MES on youth 9v9 and 0.5 MES on mini soccer 7v7 pitches. There is currently no overplay on Mini Soccer 5v5 pitches;
- There are existing shortfalls on youth 11v11 and youth 9v9 pitches in the East sub analysis area, which will increase with future demand. There is currently enough pitch provision to meet future demand for adult pitches and both mini soccer 5v5 and 7v7 pitches in the East, although mini soccer 7v7 pitches are predicted to be at capacity.
- There are current shortfalls on adult and youth 9v9 pitches in the West, which are expected to rise when future demand is considered. Future demand will also result in youth 11v11 pitches being at capacity.

3G AGP Summary – Football

- There are currently 7 3G AGPs in Broadland across 7 sites. 3 of these pitches are deemed to be full size whilst 4 are considered small sized;
- Norwich City Community Sport Foundation reported plans to start developing a second full size 3G AGP at The Nest. Through the consultation, Aylsham FC also reported an aspiration to develop a full sized 3G AGP at Youngs Park;
- All 3 full size 3G AGP's in Broadland are on the FA 3G Pitch Register;
- Thorpe St Andrew School reported that they have 4 slots a week free on their 3G pitch during off-peak periods. All other 3G AGPs in Broadland are currently at capacity;
- All 3 full size 3G AGPs were assessed as being of good quality;

- All 3 sites that provide full size AGPs also provide ancillary provision. 2 sites were assessed as having good quality ancillary provision and 1 as standard;
- There is currently demand for 6 additional 3G AGPs in Broadland. This increases to 11 when TGR's are combined with current team numbers.

Rugby summary

- There are currently 34 rugby pitches within Broadland across 10 sites. 15 of these are senior rugby pitches, there are 5 junior rugby pitches and 14 mini pitches;
- The majority of pitches are provided in the East sub analysis area, 27 (80%) in total. There are 7 (20%) in the West;
- There are currently 22 rugby pitches available for community use in Broadland, 3 of which are provided on educational sites, the remaining pitches are all located on sport club sites;
- Norwich RFC have been looking to relocate for a number of years now from their site. There were discussions previously about the club relocating to the University of East Anglia, but it is understood that this is no longer an option. A compulsory purchase order has been placed on part of their site that would impact their existing supply of rugby pitches, therefore, the club are still keen to look at a site relocation that could meet their current and future requirements;
- There are 34 rugby pitches in Broadland, 27 were assessed as poor quality and 7 were assessed as standard. No pitches were assessed as good;
- Both sites that are used by rugby clubs provide ancillary facilities that were assessed as standard quality;
- No clubs in Broadland reported any future demand to grow their clubs;
- The only actual spare capacity on rugby pitches in Broadland in on the mini pitches at Norwich RFC which currently have spare capacity of 7 Match Equivalent Session (MES) at peak times;
- There is overplay that totals 5.5 MES on rugby pitches in Broadland. The highest amount of overplay is at Norwich RFC. Sprowston Cricket Club which is home to Norwich Union Rugby club is also overplayed by 0.5 MES.
- There are current shortfalls of 5 MES on senior rugby pitches in Broadland, these increase by 0.5 MES to 5.5 MES when future demand is considered.

Hockey summary

- There are currently 2 sites in Broadland that provide full size AGPs suitable for hockey, 1 of which is a double pitch site located at the Taverham Recreational Facility. The other is a single pitch site which isn't available for community use;
- There are also 2 sites in Broadland that provide small sized AGPs suitable for hockey. Both of these pitches are available for community use;
- There are 3 hockey clubs in Broadland who between them have 30 teams. This equates to 8 senior men's teams, 11 senior women's teams, 6 junior / mini boy's teams and 5 junior / mini girl's teams. 1 of these clubs, UEA Hockey Club only cater for student from UEA;
- All hockey club demand is located at Taverham Recreational Facility where security of use is deemed to be secured;
- The AGPs at Taverham Recreational Facility were assessed as standard, whilst the ancillary provision was assessed as good;
- TGRs show up to 2 additional senior men's teams and 2 senior women's hockey teams could be created in Broadland by 2038;
- There is currently no spare capacity during mid-week peak times at the Taverham Recreational Facility. Demand modelling suggest that there is 1.5 MES of spare capacity at weekends but consultation with the site suggested they are at capacity;
- Future demand will result in all full size hockey AGPs being at capacity by 2038 in Broadland.

Cricket summary

- There are currently 24 grass cricket pitches in Broadland, 17 of these are available for community use with the remaining 7 unavailable;
- There are 3 sites that contain lapsed cricket squares, these are Acle Academy, Fireside Junior School and Sprowston Community Academy;
- There are currently 15 cricket clubs within Broadland who have a total of 101 teams. There are more teams located with the East sub analysis area (72) compared to the West (29);
- Security of tenure is deemed to be an issue at 4 sites in Broadland, Acle War Memorial Recreational Centre, Frettenham Village Hall Playing Field and Halvergate Playing Field;
- All sites containing grass cricket squares were assessed to understand their quality.13 were assessed as good, 11 as standard and 0 as poor. There were

also 5 Non-Turf Pitches (NTPs) assessed as good and 5 as standard, 0 were assessed as poor;

- Norwich Cricket Club have exported demand outside of the study area to Ingham Cricket Club in North Norfolk. This is for 1 adult Saturday team, 1 adult Sunday team and some of their junior teams on an ad hoc basis;
- Team Generation Rates (TGRs) show future demand for an additional 19 teams in Broadland;
- Ancillary provision at sites containing crickets squares was also assessed. 5 sites were assess as having good quality provision, 8 as standard and 2 as poor. Coltishall Cricket Club, Frettenham Cricket Club and Norwich Cricket Club all stated that their ancillary provision required improving;
- Whilst a number of clubs have access to nets for training sessions, Old Catton Cricket Club and Sprowston Cricket Club both stated that they had demand for additional training net provision. Some clubs also use grass wickets to train on;
- There is actual spare capacity for 2 Saturday teams, 6 Sunday teams and 24 midweek teams in Broadland;
- There are 4 sites that are currently overplayed in Broadland this totals 15 match equivalent sessions (MES).

Tennis summary

- There are 26 sites in Broadland that provide outdoor tennis courts. This equates to 80 courts in total;
- 67 of these courts are available for community use;
- 31 courts available for community use have floodlights;
- The majority of tennis courts provided in Broadland with community use have a macadam surface (82%);
- Blofield Tennis Club are looking to resurface 1 of their grass tennis courts to a macadam surface. Both Stanmore Tennis Club and Taverham Tennis Club have recently resurfaced their macadam courts;
- No provision on club sites is deemed to be unsecured. Taverham Tennis Club were on a short-term lease arrangement with the Parish Council whilst their courts were resurfaced. It is understood this has now been resolved;
- 19 tennis courts were assessed as being good quality, 43 as standard and 5 as poor;
- Blofield Tennis Club reported issues with the quality of ancillary provision at their site, this was assessed as being poor quality;

- 2 clubs in Broadland reported plans to increase their current membership numbers by a total of 140 adult members and 45 junior members between them;
- Across Broadland there is only capacity for an additional 15 members on existing club sites;
- 2 sites currently have spare capacity whilst there are 3 sites that are over capacity

Netball summary

- There is no netball league based within Broadland. Clubs access league provision in Norwich and South Norfolk;
- There are currently 13 sites in Broadland providing outdoor netball courts. This equates to 31 courts in total.
- 9 sites are available for community use which provides 18 courts in total;
- There are 12 courts located in the East sub analysis area and 6 in the West;
- Of the netball courts available for community use, 16 are a macadam surface and 2 are a concrete surface;
- 6 of the courts that are available for community use are floodlit. There are 12 netball courts that aren't floodlit;
- 1 netball court was assessed as good, 13 as standard and 4 as poor.

Bowls summary

- There are currently 19 sites in Broadland that provide bowling greens. 13 sites are located in the East sub analysis area and 6 are located in the West;
- There is 1 disused green at Woodbastick Bowls Club;
- There were 15 bowling greens assessed as good quality and 4 as standard. None were assessed as poor;
- All sites have access to some form of ancillary provision;
- Cawston Bowls Club is the only bowling green in Broadland that is floodlit.
- Based on clubs who responded to the consultation, there are currently 689 adult bowls members within Broadland and 4 junior members. With planned club growth this could increase to 757 adult members;
- There is currently spare capacity across bowling greens in Broadland for 607 members.

Football Scenarios

Improve pitch quality at key sites

2.10 Each of the 3 Local Football Facility Plans (LFFP) that were developed for Norwich, South Norfolk and Broadland contained priority projects that were identified to improve the quality of grass pitches. Sites were identified due to their strategic importance locally. In this scenario, pitches at these sites have had their quality ratings improved to look at what impact this has on pitch capacity. Quality ratings have been improved as follows, poor to standard and standard to good.

Norwich

- 2.11 The Norwich LFFP identified the following grass pitch priority projects:
 - City Academy Norwich;
 - City of Norwich School;
 - Eaton Park;
 - FDC Open Academy;
 - Recreation Road Sports Centre;
 - Sloughbottom Park.
- 2.12 Table 2.4 overleaf looks at the initial quality ratings and capacity at these sites and then looks at the impact improving the quality rating has on pitch capacity. Recreation Road Sports Centre hasn't been included in the table below, this is because the pitches were assessed as being good and therefore, the quality and capacity cannot be improved. The priority at this site will be maintaining the existing level of quality.

2.13 Table 2.4 shows the impact of improving grass pitch sites identified in the Norwich LFFP.

- 2.14 Spare capacity on pitches at these sites has increased from 16 MES to 48 MES, which represents an increase of 32 MES. It is worth noting that tenure at City Academy Norwich and City of Norwich School is deemed unsecured. If these sites were discounted, then these figure would reduce by 9 MES.
- 2.15 This scenario would help to address overplay on the youth 9v9 pitch at Eaton Park which were previously overplayed by 0.5 MES and now has spare capacity of 1.5 MES. The adult pitch at Open Academy that was previously overplayed by 1 MES would now be at capacity, likewise for the youth 9v9 pitch at this site that was previously overplayed by 2 MES.

South Norfolk

- 2.16 The South Norfolk LFFP identified the following grass pitches as priority projects:
 - Hethersett Memorial Playing Field;
 - Manor Road Playing Field;
 - Morley Village and Sports Hall;
 - Oaklands Recreation Ground;
 - Orchard Park (Mulberry Park);
 - Ormiston Victory Academy;
 - Scole Community Centre & Playing Fields;
 - Stoke Holy Cross Playing Field;
 - The Costessey Centre;
 - Wymondham area.
- 2.17 Table 2.5 overleaf looks at the initial quality ratings and capacity at these sites and then looks at the impact improving the quality rating has on pitch capacity. In terms of the reference to the Wymondham area in the LFFP, Ketts Park Community Recreation Centre has been included from this area.
- 2.18 The following sites have been omitted from the table below as they were already assessed as being good and therefore, the quality and capacity can't be improved. The priority at these sites should be maintaining quality.
 - Morley Village and Sports Hall (mini soccer pitches only);
 - Mulberry Park (adult pitch only);
 - Oaklands Recreation Ground;

- Stoke Holy Cross Playing Field;
- The Costessey Centre.
- 2.19 Table 2.5 shows the impact of improving grass pitch sites identified in the South Norfolk LFFP.

- 2.20 Spare capacity on these sites has increased from 17 MES to 55 MES, which represents an increase of 38 MES. It is worth noting that tenure at Ormiston Victory Academy is deemed unsecured. If this site was removed, capacity would reduce by 2 MES.
- 2.21 The adult football pitch at Hethersett Memorial Park that is currently overplayed, would change to being at capacity and the youth 9v9 pitch on this site would have spare capacity of 0.5 MES. The youth 11v11 pitch at Mulberry Park that is currently overplayed would change to being at capacity, whilst the youth 9v9 pitch at this site would have spare capacity of 1 MES.

2.22 Whilst this scenario would help to alleviate overplay at sites in South Norfolk, it wouldn't fully address the future shortfalls that are predicted. These are focused on youth 9v9 pitches, which currently total 6 MES. Capacity on youth 9v9 pitches is increased by 4 MES, so consideration may need to be given to reconfiguring pitches at certain sites.

Broadland

- 2.23 The Broadland LFFP identified the following grass pitch priority projects
 - Great Plumstead Village Hall;
 - Hellesdon High School;
 - Hellesdon Recreation Ground;
 - Hillside Avenue Primary School;
 - Hinks Meadow;
 - Jarrolds Sports and Social Club;
 - Rackheath Playing Fields (referred to as Stracey Recreation Ground);
 - Salhouse Recreation Ground;
 - Sir George Morse (referred to as Thorpe Recreation Ground in the LFFP);
 - Sprowston Recreation Ground;
- 2.24 Table 2.6 overleaf looks at the initial quality ratings and capacity at these sites and then looks at the impact improving the quality rating has on pitch capacity. Jarrolds Sports and Social Club hasn't been included in the table as the site is currently closed and unavailable for community use.

2.25 Table 2.6 shows the impact of improving grass pitch sites identified in the Broadland LFFP.

- 2.26 Spare capacity on these sites has increased from 30 MES to 73 MES, which represents an increase of 43 MES. It is worth noting that provision at Hellesdon High School and Hillside Avenue Primary School is deemed unsecured. If those sites were removed, capacity would reduce by 11 MES.
- 2.27 The adult and youth 11v11 pitches at Hellesdon High School would still be overplayed by 0.5 MES in this scenario. The youth 9v9 pitch at this site would have spare capacity of 0.5 MES though.

2.28 Whilst this scenario would help to address the overall capacity issues for adult pitches by increasing capacity by 10 MES, the majority of the sites above are located in the East sub analysis area, where there were no shortfalls. Future shortfalls of 5 MES were identified in the West sub analysis area on adult pitches. Considerations will need to be given to targeting sites within this sub analysis area. This scenario also wouldn't fully address future shortfalls on youth 11v11 and youth 9v9 pitches. Consideration should be given to reconfiguring sites with spare capacity of other pitch types.

Moving mini soccer match play to 3G AGP's

2.29 This scenario looks at how many 3G AGPs would be needed in each Local Authority area to cater for mini soccer (5v5 and 7v7) fixtures. Peak demand for mini soccer across the 3 Local Authority areas is Saturday 10am – 12pm. This has been calculated on the basis that each 5v5 match requires a quarter of a 3G AGP for 30 mins and a 7v7 match requires half a 3G AGP for 60 minutes. Should fixture scheduling be more flexible in the future then the figures stated below would reduce.

Norwich

2.30 There are 15 mini soccer teams in Norwich at present meaning that there would be demand for 3 hours of match play on 1 3G AGP that was FA or FIFA certified. On this basis this current demand could be met on existing 3G AGP's in Norwich

South Norfolk

2.31 There are currently 95 mini soccer teams in South Norfolk, which would require 9 (rounded up from 8.9) 3G AGP's to cater for all mini soccer match play.

Broadland

2.32 There are currently 121 mini soccer teams in Broadland, which would require 13 (rounded up from 12.5) 3G AGPs to cater for all mini soccer match play.

Consolidating match play on council park sites in Norwich

- 2.33 There are currently 4 council parks sites in Norwich that provide football pitches for matches. These are:
 - Britannia Barracks;
 - Eaton Park;
 - Sloughbottom Park;
 - The Fountain Ground.

- 2.34 This scenario looks at whether demand across these 4 sites could be consolidated at one site. Across the 4 sites there is currently 5.5 MES of use on adult pitches. Therefore demand could be met on 6 adult pitches. There is currently demand of 2 MES on youth 11v11 pitches which would require 2 youth 11v11 pitches. There is also demand of 2 MES for youth 9v9 pitches which would require 2 pitches. There is demand of 1 MES for mini soccer 7v7 pitches meaning demand could be met on 1 pitches. There is currently no demand for mini soccer 5v5 pitches being accounted for at any of the 4 sites.
- 2.35 Based on current demand the following pitch configurations would be required cater for all demand that is currently spread across the 4 sites.
 - 6x adult pitches;
 - 2x youth 11v11 pitches;
 - 2x youth 9v9 pitches;
 - 1x mini soccer 7v7 pitch.
- 2.36 This is based on teams playing home and away fixtures that take place at the same time. This could be reduced if appropriate fixture scheduling was considered.

Recommendations for football

- Look at improving pitch quality on key sites for football through improved maintenance. Sites should be encouraged to access the Pitch Power app to gain support on how to better maintain pitches and consider appropriate funding opportunities via the Football Foundation;
- Protect existing football sites, unless provision can be adequately re-provided as per Sport England's Playing Fields Policy Exception E4;
- Provide sufficient 3G AGP provision in the right locations to meet the shortfalls that have been identified;
- Where new 3G AGPs are provided, ensure that they are constructed to the correct standard in order to be included on the FA 3G register. It may also be appropriate to explore opportunities to deliver pitches that are also compliant with RFU specifications, to cater for any rugby training demand that exists.
- Ensure any existing 3G AGPs that appear on the FA 3G Register remain there and continue to cater for affiliated matches. Also ensure these pitches are resurfaced to the appropriate standard when required;
- Where appropriate, support clubs and sites to provide suitable ancillary provision to cater demand;
- Look at securing tenure on sites that are deemed to be unsecured.

Rugby scenarios

Increase female participation

- 2.37 Increasing women's rugby participation is one of the priorities identified in the England Rugby Strategy. England hosting the Women's Rugby World Cup in 2025 is anticipated to generate a 15% to 20% growth in women's rugby.
- 2.38 Whilst the assessment report calculates team generation rates (TGRs) based on known housing and population growth, the baseline for generating future growth is existing team numbers. If a club currently has minimal female provision, no future demand will be generated. In this scenario, existing female team numbers have been used as the baseline, and then increased by 20% in line with RFU recommendations to generate future demand. This has been reviewed against existing supply and demand information to look at what impact this would have on pitch provision.

South Norfolk

2.39 There are currently 4 senior women's teams in South Norfolk, which would increase to 5 (rounded up from 4.8), therefore future demand from senior women's teams would be 2.5 Match Equivalent Sessions (MES), which represents an increase of 0.5 MES. Table 2.7 below shows the impact this would have on existing senior rugby pitches.

- 2.40 Should this new demand also train on floodlit pitches, then this shortfall would increase again to 17.75 MES.
- 2.41 There are currently 9 junior girl's teams which would increase to 11 teams (rounded up from 10.8), therefore future demand from junior girl's teams would be 5.5 MES, which represents an increase of 1 MES based on current demand.

2.42 Table 2.8 shows the impact this would have on existing rugby pitch provision in South Norfolk.

- 2.43 Table 2.8 shows that there would be a future shortfall of 1 MES for junior rugby pitches in South Norfolk based on this scenario. This is based purely on match play. If this increased women's demand also trained on a floodlit rugby pitch, it will impact the capacity of those too.
- 2.44 There are currently 5 floodlit rugby pitches in South Norfolk that are overplayed by 16.25 MES when match play and training are considered. This would increase to 17.25 MES if the increased women's demand was to train on a floodlit rugby pitch.

Broadland

2.45 There are currently 0 senior women's teams in Broadland. The RFU envisage that the 3 junior girls teams that exist will translate in to 1 senior team in the future. Therefore future demand from senior womens teams in Broadland would be 0.5 MES. Table 2.9 below show the impact this would have on existing senior rugby pitches.

- 2.46 Should this new demand also train on a floodlit pitches, then this shortfall would increase to again to 5.5 MES.
- 2.47 There are currently 3 junior girl's teams which increases to 4 (rounded up from 3.6). Therefore, future demand from junior girl's teams would be 2 MES, which is an increase of 0.5 MES.

2.48 Table 2.10 shows the impact this would have on existing junior rugby pitch provision.

2.49 Table 2.10 shows that there would be a shortfall of 0.5 MES based on this scenario. This is based purely on match play, if this increased women's demand was to also train on floodlit rugby pitches, then it would impact the capacity of those too. There is currently 1 floodlit rugby pitch in Broadland which is overplayed by 4 MES. This would increase to 4.5 MES.

Norwich

2.50 This scenario hasn't been considered in Norwich because there is currently no club demand in the Local Authority area. All rugby club demand is catered for within the neighbouring Local Authority areas, which the RFU are happy with.

Improve Pitch Quality

- 2.51 the RFU have developed a partnership with the Grounds Management Association (GMA). This enables clubs to complete a self-assessment of their pitches via the Pitch Power app. This provides clubs with a report completed by a GMA Regional Pitch Advisor that assesses each pitch using a performance quality standard (PQS). Clubs also receive advice on how to improve pitch quality through improved maintenance practises. The RFU are supporting clubs to access this service with a view to improving pitch quality and capacity on club sites.
- 2.52 This scenario looks at the impact this would have if each pitch on a club sites maintenance score was improved from poor to standard (M0 to M1) or standard to good (M1 to M2).

South Norfolk

2.53 Table 2.11 shows rugby club sites in South Norfolk with their current maintenance score and capacity rating. The maintenance scores have then been improved with the new capacity rating shown.

2.54 Whilst this would improve capacity at all sites by an additional 20.25 MES per week, there would still be significant capacity issues at Crusaders Rugby Football Club and Diss Rugby Club. One option could be to provide additional floodlit pitches at these sites. Both sites currently have 1 floodlit pitch which caters for midweek training. Reducing the burden on these pitches would help to improve the overall site capacity.

Broadland

2.55 Table 2.12 shows rugby club sites in Broadland with their current maintenance score and capacity rating. The maintenance scores have then been improved with the new capacity rating shown.

2.56 Whilst this would increase capacity on all sites by a total of 8 MES per week, there would still be shortfalls on the senior pitches at Norwich RFC. One option could be to provide additional floodlights at the site. It currently has 1 floodlit pitch which caters for midweek training. Reducing the burden on this pitch will help to improve the overall site capacity.

Norwich

2.57 There are no rugby club sites in Norwich, so this scenario hasn't been applied. As previously noted, all rugby club demand is catered for in the neighbouring Local Authorities.

Recommendations for Rugby

- Ensure that rugby clubs across the 3 Local Authority areas access the new scheme delivered in conjunction with the Grounds Management Association (GMA) to seek guidance on better pitch maintenance through the Pitch Power app;
- Protect existing rugby sites, unless provision can be adequately re-provided as per Sport England's Playing Fields Policy Exception E4;
- Look at providing additional floodlights on club sites to alleviate capacity issues, where club training and fixtures take place on the same pitch;
- Support Crusaders Rugby Club and Lakenham Hewett Rugby club improve their ancillary provision;
- Support Norwich Rugby Club with relocation to a suitable site to ensure there is no impact from potential loss of provision relating to the Compulsory Purchase Order that has been placed on part of their site;
- Support Diss Rugby Club to identify and develop additional land in order to provide additional pitches and reduce overplay on their senior pitches;
- Where appropriate, support clubs to access 3G AGP provision for training, to help alleviate capacity issues on club sites.

Hockey scenarios

Loss of unsecured sites

- 2.58 This scenario looks at the impact the loss of unsecured provision would have on hockey clubs within the respective Local Authorities.
- 2.59 There are currently 2 hockey clubs in Norwich who access unsecured provision-Norfolk Nomads and UEA Hockey club. Both clubs are currently accessing the hockey AGPs at Sportspark for training and matches.
- 2.60 The 2 hockey clubs currently using the 2 hockey AGPs at Sportspark require 6 match equivalent sessions (MES) of use per weekend between them. Given that a full size hockey AGP can cater for 4 matches per Saturday and Sunday, if this provision was no longer available, 2 new hockey AGPs would need to be provided to meet this demand.
- 2.61 There are 3 clubs in South Norfolk who are accessing unsecured provision, they are Carrow Hockey Club, Loddon Ladies Hockey Club and Beccles Ladies Hockey Club. All of these clubs are accessing the hockey AGP at Langley School for training and matches. It is worth noting that Beccles Ladies Hockey Club is imported demand from Suffolk. England Hockey don't envisage there being sufficient hockey facilities in Beccles to cater for this demand.

- 2.62 If the pitch at Langley School was no longer available, the 2.5 MES of demand that the 3 clubs currently have between them would need to be catered for elsewhere in the Local Authority area. This would require an additional full-size hockey AGP to be provided. The only other full-size hockey AGP in South Norfolk that is available for community use is at Hobart High School, where provision is also deemed to be unsecured.
- 2.63 There is currently no hockey played on unsecured sites in Broadland.

Recommendations for hockey

- Look to secure provision on sites that are currently unsecured;
- Protect existing hockey sites, unless provision can be adequately re-provided, as per Sport England's Playing Fields Policy Exception E4;
- Ensure that existing hockey AGPs are appropriately maintained and resurfaced to the appropriate standard when required;
- Support TCH Dragons to develop ancillary provision at TCH Dragons Den.
- Ensure that there is sufficient capacity to allow for junior programmes, as well as training and match play.

Cricket Scenarios

Improving the quality of club sites

2.64 This scenario looks at the impact of improving the quality of grass cricket squares on sites used by cricket clubs in each of the 3 Local Authorities. Squares have been improved by 1 increment, for example poor to standard and standard to good. Any squares that were originally assessed as good have been omitted from the tables below as they cannot be improved any further. Match equivalent sessions (MES) for cricket in the assessment report are per season.

Norwich

2.65 There is currently only 1 site in Norwich that is used by cricket clubs, that is City of Norwich School. The impact of improving quality at this site is shown in table 2.13 below.

2.68 Based on this scenario, capacity on cricket club sites would increase from 224 MES to 280 MES per season, an increase of 56 MES per season. Whilst capacity has increased, 5 sites still remain overplayed, this amounts to 92 MES per season. As all sites would now be classified as good, consideration may need to be given to additional non-turf pitches (NTPs) being provided or better use of existing NTP's. Alternatively, consideration may need to be given to providing additional squares.

Broadland

2.69 Table 2.15 shows the impact of improving the quality of grass cricket squares on club sites in Broadland based on the same criteria set out in the two previous Local Authorities.

2.70 Based on this scenario, capacity on club sites would increase from 216 MES to 270 MES per season, an increase of 54 MES per season. This would help to alleviate all overplay issues on cricket club sites in Broadland

Loss of unsecured sites

- 2.71 Both cricket clubs in Norwich currently access unsecured provision. There are 7 cricket clubs in South Norfolk currently accessing unsecured provision. Whilst the assessment report identified that Swardeston Cricket Club were accessing unsecured provision, it is understood through consultation with Norfolk County Cricket board that this has now been resolved. Therefore, they haven't been included within this scenario. There are 4 cricket clubs in Broadland currently accessing unsecured provision.
- 2.72 There is currently 48 MES per season played at the City of Norwich School which is deemed unsecured. If provision at this site can't be secured, the only site in Norwich deemed secure is Britannia Barracks which was assessed as poor and has no capacity due to informal use. Therefore, if it was required it's quality would need to be improved.
- 2.73 There is currently 353 MES per season played on unsecured sites in South Norfolk. Given the shortfalls that exist on cricket sites, this demand would not be able to be accommodated elsewhere. Therefore, the priority should be to look at securing use at these sites.
- 2.74 There is currently 190 MES per season played on unsecured sites in Broadland. Overall, there is a shortfall of cricket pitches in Broadland, so it wouldn't be possible to cater for this demand elsewhere. Therefore, the priority should be to look at securing use at these sites.

Recommendations for cricket

- Protect existing cricket sites, unless provision can be adequately re-provided, as per Sport England's Playing Fields Policy Exception E4;
- Look at improving the quality of club sites where possible;
- Work to secure provision at club sites that are currently deemed to be unsecured;
- Look at greater use of NTPs for fixtures and training to help alleviate capacity issues on certain sites;
- Support Norwich Cricket Club, Frettenham Cricket Club, Brooke & District Cricket Club, Great Melton Cricket Club, Hales and Loddon Cricket Club and Aylsham St Giles Cricket Club to upgrade existing pavilions, or provide new ones where required;

- Support Sprowston Cricket Club, and Brooke & District Cricket Club to develop new squares;
- Explore opportunities for new cricket provision at sites such as the proposed development at the Long Stratton Hub and Silfield in Wymondham.

Non-Pitch Sport Recommendations

Recommendations for Tennis

- Look at resurfacing poor quality courts to improve quality and increase capacity;
- Look at providing floodlights for non-floodlit tennis courts to increase capacity;
- Look at resurfacing the grass tennis courts at the Hewett Academy and Cringleford Tennis Club to a macadam surface to increase capacity;
- Support Wymondham Tennis Club and Blofield Tennis Club improve their ancillary provision;
- Look at bringing disused tennis courts back in to use such as the courts at the Hewett Academy and County Hall.
- Look at providing gate access to sites that don't currently provide this service to improve access. Linked to the LTA Rally programme (<u>Click for LTA Rally</u>).

Recommendations for Netball

- Look at resurfacing the netball courts at Hellesdon High School and City Academy Norwich;
- Look at resurfacing poor quality courts to improve quality and increase capacity. When this is looked at, consideration should be given to providing Gen 2 surfaces which can cater for multiple sports;
- Look at improving poor quality ancillary provision on any sites used by netball clubs;
- Work to secure use on sites currently deemed unsecured for netball clubs.

Recommendations for Bowls

- Support clubs to maintain the quality of their greens;
- Look at improving the quality of any poor bowling greens such as those at Alderman Walker Park and Heigham Park;
- Support bowls clubs to improve their ancillary provision where required.

Strategic Recommendations

3.1 The strategic recommendations within this strategy are based on the aims set out by Sport England within their Playing Pitch Strategy guidance. These are Protect, Enhance and Provide. They have been informed by consultation and research that has been carried out throughout the process of developing this strategy.

Protect

Protect sites through planning policy

- 3.2 Sport England's PPS guidance uses the following definitions of a playing pitch and playing field. These definitions are set out by the Government in the 2015 'Town and Country Planning (Development Management Procedure) (England) Order'. It should be noted that the reference to 5 years is purely in relation to whether Sport England should be consulted in a statutory capacity. The fact that a playing field may not have been marked out for pitch sport in the last 5 years does not mean that it is no longer a playing field this remains its lawful planning use whether marked out or not:
 - **Playing pitch** a delineated area, which is used for association football, rugby, cricket, hockey, lacrosse, rounders, baseball, softball, American football, Australian football, Gaelic football, shinty, hurling, polo or cycle polo;
 - **Playing field** the whole of a site which encompasses at least one playing pitch.
- 3.3 Although the statutory definition of a playing field is the whole of a site with at least one pitch of 0.2ha or more, this PPS considers smaller sized pitches that contribute to pitch stock, for example, 5v5 mini soccer pitches.
- 3.4 The National Planning Policy Framework (NPPF) sets out the governments planning policies for England and how these should be applied. Paragraph 98 emphasises the importance of access to high quality open spaces and opportunities for sport and physical activity for the health and wellbeing of communities. Paragraph 99 also states that such facilities shouldn't be built on or developed unless:
 - an assessment has been undertaken which has clearly shown the open space, buildings or land to be surplus to requirements; or
 - the loss resulting from the proposed development would be replaced by equivalent or better provision in terms of quantity and quality in a suitable location; or

• the development is for alternative sports and recreational provision, the benefits of which clearly outweigh the loss of the current or former use.

Lapsed and disused sites

- 3.5 A lapsed site is one that hasn't been used for 5 years or longer and now falls outside of Sport England's statutory remit but is still assessed using the criteria within Paragraph 98 of National Planning Policy Framework.
- 3.6 A disused site is one that isn't currently being used. Once a site has been disused for 5 years or more it will then be classed as lapsed;
- 3.7 Lapsed and disused sites that were identified during the development of this strategy are shown in table 3.1.

- 3.8 The PPS has identified a number of shortfalls across various pitch types in each of the 3 Local Authorities, therefore these sites shouldn't be deemed surplus to requirements where they are still available, unless one of Sport England's policy exceptions can be met, these are:
 - Exception 1 A robust and up-to-date assessment has demonstrated, to the satisfaction of Sport England, that there is an excess of playing field provision in the catchment, which will remain the case should the development be permitted, and the site has no special significance to the interests of sport;
 - Exception 2 The proposed development is for ancillary facilities supporting the principal use of the site as a playing field, and does not affect the quantity or quality of playing pitches or otherwise adversely affect their use;
 - Exception 3 The proposed development affects only land incapable of forming
 part of a playing pitch and does not reduce the size of any playing pitch. Does
 not result in the inability to use any playing pitch (including the maintenance of
 adequate safety margins and run-off areas), reduce the sporting capacity of the
 playing field to accommodate playing pitches or the capability to rotate or
 reposition playing pitches to maintain their quality or result in the loss of other
 sporting provision or ancillary facilities on the site. Does not prejudice the use of
 any part of a playing field and any of its playing pitches;

- Exception 4 The area of playing field to be lost as a result of the proposed development will be replaced, prior to the commencement of development, by a new area of playing field of equivalent or better quality, of equivalent or greater quantity, in a suitable location that is subject to equivalent or better accessibility and management arrangements;
- Exception 5 The proposed development is for an indoor or outdoor facility for sport, the provision of which would be of sufficient benefit to the development of sport as to outweigh the detriment caused by the loss, or prejudice to the use, of the area of playing field.

Secure tenure on unsecured sites

- 3.9 A number of educational, private, and commercial sites are currently being used by clubs within each of the 3 Local Authorities where tenure is deemed unsecured. Where possible the relevant NGB should look to work with those clubs to seek to provide an agreement that helps to secure use of the site for that club.
- 3.10 Clubs who currently have agreements in place with sites should be supported to renew these when required to ensure that use of that site remains secured.

Enhance

Improve pitch quality

- 3.11 The Ground Management Association (GMA) now runs a pitch improvement programme that covers football, rugby and cricket. Through this programme clubs can seek advice on how to better manage and maintain their pitches. In the case of football there is also funding available via the Football Foundation to support clubs in this programme purchase maintenance kit or buy in contractor maintenance services.
- 3.12 Where possible, clubs should be supported to access this programme and follow the recommendations that have been identified. This may relate to increasing the amount or frequency of maintenance that is carried out. In certain instances, improving pitch quality will help to alleviate overplay on sites. A number of sites where this could be achieved have been identified within the Action Plan.

Improve ancillary provision

3.13 A number of sites have been identified across the 3 Local Authorities where ancillary provision either isn't available, is insufficient or of poor quality. The Action Plan identifies a numbers of sites where new or improved ancillary provision is required to meet demand. Clubs or sites that have been identified should be supported to improve or develop ancillary provision.

Securing funding

3.14 Where possible, any funding secured should be directed to priorities identified within the Action Plan. Members of the steering group should work collaboratively to identify funding opportunities and align them to the strategic priorities identified.

Developer contributions

- 3.15 This strategy should inform planning policies relating to any new housing developments and requirement for playing pitches and facilities. The 3 Local Authorities should endeavour to work with Sport England to secure developer contributions via Section 106 or Community Infrastructure Levey (CIL). Where new developments are provided Sport England's Facility Calculator may also be used to determine the level of provision required. (Click here for Sport England's Sport Facility Calculator)
- 3.16 To determine what provision is provided, it is imperative that the PPS is used, and that consultation is carried out with the relevant NGBs as part of the planning process. This will ensure that the facilities provided are correct and avoid provision becoming unsustainable and unused. This is of particular importance in areas where large scale regeneration and housing growth is being undertaken, such as East Norwich, Rackheath and Beeston Park.

Provide

Improve facilities to meet demand

- 3.17 The Action Plan identifies a number of sites where improvements can be made to facilities in order to meet current and future demand. It is important that the steering group work together to help deliver these actions and ensure that current and future demand can be catered for.
- 3.18 The steering group should also work together to update the PPS, identifying where actions have been delivered and the impact this has on provision and demand locally.

Reconfigure pitches

3.19 There have been sites identified where there is an oversupply of certain pitch types or pitches that are unused. These shouldn't be deemed surplus to demand. The steering group should work together to look at reconfiguring these pitches to meet any identified shortfalls of certain pitch types. Relocating demand from overplayed pitches to these sites will also help to address overplay issues.

Action Plan

Introduction

- 4.1 This section of the report provides an action plan that looks at recommendations on a site-by-site basis. This has been set out for each of the 3 Local Authority area's and divided into relevant sub analysis areas for each.
- 4.2 The action plan columns are set out as follows:
 - Site name the name of the site that is being referred to;
 - Sub analysis area the sub analysis area with the Local Authority that the site is located in;
 - PPS site ID the unique ID number that has been allocated to the site for the PPS;
 - Management type the current management arrangement;
 - Current status the pitches / courts located at the site including their quality and current status, i.e. overplayed, at capacity or spare capacity;
 - Recommendation –. what has been recommended to help meet the priorities identified within the PPS;
 - Responsibility which partners will be responsible for delivering any outcomes and outputs at the sites;
 - Priority if the recommendation is a **High**, **Medium** or **Low** priority. Priorities have been determined through consultation with the PPS steering group;
 - Timescale whether the recommendation is a short term priority (1-2 years) medium term priority (3-5 years) or long term priority (6 years +);
 - Aim which of the aims to the site fall under. Protect, Enhance or Provide (a site could meet all three of these aims).
- 4.3 It may also be appropriate for consideration to be given to the cost of delivering the projects identified in the Action Plan. Sport England provide guidance on this (Click here for Sport England facility cost guidance).
